Existing medical conditions	Asthma, allergies, physical disabilities, hay fever	<ul style="list-style-type: none"> <li>LH staff to check and familiarise all medical details before arrival of group</li> <li>Check/get updated medical details before activities</li> <li>Check that medicines are taken off site with group if needed, ie. Inhalers</li> <li>LH staff to adjust route/activity/pace to meet individual needs of the group</li> </ul>
Exposure/weather conditions	Sunburn, hypothermia, dehydration, high winds	<ul style="list-style-type: none"> <li>Check weather forecasts before departing.</li> <li>Brief everyone on equipment and clothing required.</li> <li>Staff to check if children have correct clothing/equipment.</li> <li>LH Staff to take additional suncream, sun hats, woolly hats, warm clothing, extra water etc</li> <li>Avoid certain routes if necessary, ie. High winds near cliff edge</li> </ul>
Remote location	Injury/illness in remote locations some distance from help/contact No phone/mobile signal	<ul style="list-style-type: none"> <li>Leader to know nearest escape routes and points of contact/help</li> <li>Inform LH of expected route taken and timings</li> <li>Have charged mobile phone with them and OS map</li> <li>Carry First Aid kit.</li> <li>Keep staff/pupil ratios.</li> </ul>
Uneven surfaces, slippery, muddy	Trip hazards, falling in mud	<ul style="list-style-type: none"> <li>Routes not recently used will be checked by LH staff</li> <li>Alternative routes to be used if required.</li> <li>First Aid kit always with LH staff</li> <li>Staff ratios maintained.</li> <li>Keep group informed about difficult conditions as they approach them.</li> </ul>
Farm animals, stray dogs, adders and ticks	Attack, charging, bites, scared of, Lyme disease from tick bite	<ul style="list-style-type: none"> <li>LH to recce routes first and check for livestock whenever possible</li> <li>Choose alternative route whenever possible.</li> <li>LH to tell groups about suitable behaviour near livestock and dogs</li> <li>Inform group about snakes, keep away from them and do not pick up.</li> <li>Staff ensure that everyone does a thorough check after going in long grass. If any ticks are found a proper tick removal tool is to be used (in the first aid kit in the main office). Teachers inform parents if a tick has bitten a child, so parents can monitor the child &amp; take them to a doctor if Lyme disease is suspected.</li> </ul>
Getting lost	Leader losing the way, unfamiliar with the route (incl' at night), losing pupils	<ul style="list-style-type: none"> <li>Leader must be familiar with the route beforehand.</li> <li>Leader to leave note of intended route and return time back at Leeson House, carry mobile phone that is switched on.</li> <li>Keep regular count of pupils throughout activity</li> </ul>

Coastal paths, including cliff edges	Narrow, cliff edges, danger of falling	<ul style="list-style-type: none"> <li>• Keep in single file where necessary</li> <li>• Explain danger to group</li> <li>• Maintain staff ratios, with staff spaced out.</li> <li>• Use staff to help avoid certain areas.</li> <li>• Avoid certain parts of the Coastal Path – see individual risk assessments for more detail.</li> </ul>
Electric fences and Barbed Wire Fences	Electric shock from electric fences Cuts from barbed wire	<ul style="list-style-type: none"> <li>• Brief pupils about not touching fences.</li> <li>• Single file where required.</li> <li>• Maintain staff spaced out.</li> </ul>
Traffic/Roads	Children straying off the pavements Not being seen by traffic Drivers choosing to pull out around parked vehicles	<ul style="list-style-type: none"> <li>• Children briefed to stay in single file and to be aware of traffic at all times</li> <li>• Staff to lead group and also to be at rear of group. Staff to wear a reflective waistcoat at all times</li> <li>• Be aware of vehicles overtaking parked vehicles, especially when crossing roads</li> </ul>
Road Crossings	Children crossing the road in an uncontrolled manner. This includes crossing side roads.	<ul style="list-style-type: none"> <li>• Children to cross roads under strict supervision by staff, with clear briefing beforehand</li> <li>• If crossing by parked cars staff MUST ensure that there are no vehicles likely to pull out around a parked vehicle</li> <li>• Staff to wear reflective waistcoats</li> </ul>
Members of the Public	Abduction, nuisance behaviour from public in town/village.	<ul style="list-style-type: none"> <li>• Report any incident to Police.</li> <li>• Brief group about their behaviour while working in town/village</li> <li>• Keep regular count of pupils.</li> <li>• Keep staff spaced out.</li> <li>• Leader to have a working Mobile Phone with them.</li> </ul>
Stiles and gates	Unsafe stiles and gates. Unsupervised climbing of stiles can result in injury	<ul style="list-style-type: none"> <li>• Explanation of how to climb stiles safely.</li> <li>• Adults to supervise</li> <li>• One at a time through narrow gateways</li> </ul>
Sea/Rivers	Drowning, rouge waves from passing boats, rising tides, fast flowing areas of rivers, open cuts/grazes leading to infection	<ul style="list-style-type: none"> <li>• Leader to recce river conditions and know tide times</li> <li>• Always carry throw line(s)</li> <li>• Cover open cuts/grazes.</li> <li>• No swimming/paddling unless lifeguard is present</li> <li>• See individual risk assessments for more detail.</li> </ul>
