1	<b>Location</b>	Illness / accident in a semi-remote location	<ul style="list-style-type: none"> <li>Leader must be familiar with the area under the prevailing conditions and choose working areas and activities appropriate to the conditions and group</li> </ul>
2	<b>Traffic in car parks</b>	Traffic in car park	<ul style="list-style-type: none"> <li>Brief group members about the traffic in Car Parks.</li> </ul>
3	<b>Exposure</b>	Inadequate clothing for conditions There is limited shelter in this area	<ul style="list-style-type: none"> <li>Ensure the group is adequately equipped and that a weather forecast is obtained. Carry additional clothing / sun cream / water if required</li> <li>Carry KISU in appropriate conditions</li> <li>Be prepared to change plans if area chosen is exposed to the wind / weather.</li> </ul>
4	<b>Cliff edges / bases –</b>	Cliff edges with long drop, loose rock in cliffs	<ul style="list-style-type: none"> <li>Brief all group members to be aware of cliff edges and to keep away from tops and bases of cliffs. The cliff edges are mostly unfenced.</li> <li>Leader must be in front at all times and all other adult helpers must remain vigilant AT ALL TIMES</li> </ul>
5	<b>Slippery surfaces on Groynes</b>	Tripping / falling / sliding if wet	<ul style="list-style-type: none"> <li>Brief all group members to take care on all groynes</li> <li>Brief all group members to especially avoid walking on green algae covered areas and the edge of the Long Groyne.</li> </ul>
6	<b>Adders and Dogs</b>	Bite and dog mess / dog attack	<ul style="list-style-type: none"> <li>Brief pupils to keep an eye open for adders and avoid</li> <li>Brief pupils to keep an eye open for dog mess and to take care if approached by dogs off leads</li> </ul>
7	<b>Sea / Waves</b>	Sea	<ul style="list-style-type: none"> <li>Check tide tables beforehand</li> <li>Carry throwline and have it to hand at all times.</li> <li>Brief pupils to stay out of the sea and to avoid ferry slipway / quay at end of the spit</li> <li>Siphonophore – In the summer of 2017/18 a number of Portugese Man O'War were washed up onto the beaches. These sting even when washed up. Do not allow students near.</li> </ul>
8	<b>Whole area</b>	Beach / Stranger Danger	<ul style="list-style-type: none"> <li>Ensure that pupils always work together in groups</li> <li>Ensure that all groups have a mobile phone and phone numbers for staff</li> <li>Ensure that all groups know where staff will be located during group work sessions</li> </ul>
9	<b>Ongoing construction</b>		<ul style="list-style-type: none"> <li>In 2018 some of the groynes were replaced and new rock armour has been added. Tell students to stay away from any construction areas.</li> </ul>
