Injury from net handles	<ul style="list-style-type: none"> • Ensure there is correct staff ratio. • Have the nets ready by the pond for young students. • Explain hazards of waving handles around.
Falling into pond and getting wet/cold/dirty	<ul style="list-style-type: none"> • Ensure there is correct staff ratio. • No pupils to enter the pond area without a member of staff • Max 5 students per platform at any time. • Check the platforms beforehand. – can be slippery. • Ensure that leaves and grass cuttings are swept off the platforms regularly. • Explain that the water is 1m deep and no-one must enter the pond and explain that no-one may access the pond except from the dipping platforms. • Wash hands properly afterwards
Drowning	<ul style="list-style-type: none"> • Ensure there is correct staff ratio. • No pupils to enter the pond area without a member of staff • Explain that the water is 1m deep and no-one must enter the pond and explain that no-one may access the pond except from the dipping platforms.
Health risks of water and disease (Weils disease)	<ul style="list-style-type: none"> • Staff to brief pupils to check for open cuts and if required to cover with plasters / gloves • Pupils instructed to keep hands away from mouth/face. • All pupils to wash hands thoroughly after activity. • No eating/drinking during activity.
Emergency	<p>Leeson House staff to carry First Aid kit during activity. Further first aid kit, torch and phone are located in the classrooms.</p> <p>Assistance available for the office (internal phone number 221 or 222) or overnight supervisor (233) Emergency Services – Dial 9 first if using Leeson phone then 999 or 112</p>

Injury from Bird Hide Windows – windows hitting heads, hands, trapping fingers	<ul style="list-style-type: none"> • Staff to open / close all windows and to ensure that windows are secured
Nut Allergies	<ul style="list-style-type: none"> • Check medical records and exclude pupils if necessary
Binocular straps- risk of strangling	<ul style="list-style-type: none"> • Brief pupils to carry binoculars carefully
Crowding	<ul style="list-style-type: none"> • Ensure an appropriate number of pupils are using the hide at any given time and that there is always a member of staff supervising in the bird hide.
Emergency	<p>Nearest first aid kit, torch and phone are located in the classrooms</p> <p>Assistance available for the office (internal phone number 221 or 222) or overnight supervisor (233) Emergency Services – Dial 9 first if using Leeson phone then 999 or 112</p>
